

OF THE OLIY MAJLIS OF THE REPUBLIC OF UZBEKISTAN, REGIONAL, DISTRICT AND CITY KENGHASHES OF PEOPLE'S DEPUTIES: SIGNIFICANT STEP TOWARD INTENSIFYING DEMOCRATIC SOCIO-ECONOMIC AND POLITICAL REFORMS

On december 27, 2009, elections were held to the Legislative Chamber of Oliy Majlis of the Republic of Uzbekistan and other representative bodies of power in regions.

In accordance with legislation in Uzbekistan, organization and holding elections to the Legislative Chamber of parliament has been carried out by the Central Election Commission, district and constituency election commissions that form the basis and integrity of the independent electoral system. Commissions at all levels, guided by principles of legality, collegiality, transparency, independence, justice defined by legislation, made all necessary efforts to conduct genuinely democratic elections, to ensure free expression of will be the electorate.

Preparation and holding of elections in full accordance with national legislation and democratic principles of openness,transparency,justice,universal,equal and direct suffrage by secret ballot, stipulated in the Constitution of the Republic of Uzbekistan, in the Law «On elections to the Oliy Majlis of the Republic of Uzbekistan», «On guarantees of voting rights for citizens» and other

legislative acts in force in the country that regulate the electoral process.

In order to ensure the election campaign in complete accordance with the law, at high democratic level, the Central Electoral Commission approved the Concept of preparations and holding of elections to Oliy Majlis of the Republic of Uzbekistan, regional, district and city Councils of People's Deputies. Corresponding schedule of activities, all regulatory acts were developed defined by the law: directives and regulations on financing and the use of funds for preparation and holding of elections, organization of district election commissions, procedure for the nomination of candidates from the Environmental Movement of Uzbekistan to the Legislative Chamber of parliament and their election, and other issues.

In accordance with the law, 135 territorial constituencies for elections to the Legislative Chamber of parliament were created, lists of which, with their boundaries and the number of electorate in them, as well as information about the personnel of constituency electoral commissions, were published in the press on time.

In their composition, electoral commissions included respected members of public whose nominations had been widely discussed at meetings of Jokargy Kenes of the Republic of Karakalpakstan, regional and Tashkent city councils of deputies and were recommended for approval by the Central Election Commission.

District election commissions set up 8,447 polling stations, including in 44 representative missions of the Republic Uzbekistan in foreign countries, and constituency electoral commissions were instituted.

Particular attention was paid to ensuring the openness, transparency and fairness of the electoral process. Central Election Commission signed agreements to cover the preparation and holding of elections to Oliy Majlis of the Republic of Uzbekistan with the National Television and Radio Company of Uzbekistan, Creative Union of Journalists of Uzbekistan, Public Fund for the Support and Development of Independent Print Media, news agencies of Uzbekistan, and the National Association of Electronic Mass Media.

The major reason for cooperation of the Central Election Commission with the media is to create all the necessary conditions for the electorate to have a comprehensive insight into election programs of political parties and their candidates, to facilitate an informed vote on election day. Information on the preparation and conduct of elections was timely and broadly disseminated on central and local television and radio, government as well as private print media and news agencies of the republic.

All the activities of election commissions, including meetings of the CEC, district and constituency electoral commissions were carried out with the participation of media representatives. Regularly, thematic TV and radio programs were aired, and channels broadcast information videos explaining stipulations of electoral legislation: «Elections are the Mirror of Democracy», «News bulletin of the Central Electoral Commission», and others. Central Election Commission published a series of brochures on basis of electoral law, the preparation and holding of elections to the Legislative Chamber of parliament, participation of political parties and the Environmental Movement of Uzbekistan in

the elections, carrying out election campaign, guaranteeing voting rights of citizens.

2009 elections were held in a significantly increased activity of political parties. In the election campaign all four political parties registered in the country actively participated. During the elections to the Legislative Chamber of Oliy Majlis of Uzbekistan, the Central Election Commission registered 517 candidates nominated by the Social Democratic Party of Uzbekistan «Adolat», Democratic Party of Uzbekistan «Milly Tiklanish», Movement of Entrepreneurs and Business people — Liberal Democratic Party of Uzbekistan, and People's Democratic Party of Uzbekistan.

All political parties and their candidates for parliamentarians were granted equal rights to contend in the election campaign in accordance with the law. To conduct pre-election campaign they were presented with equal airtime on television and radio and equal room in print mass media. This opportunity was effectively used by all the participants in the election campaign.

CEC undertook measures to publish the electoral propaganda materials in sufficient quantities in compliance with principles of providing equal opportunities for political parties and their candidates. This included posters with biographical data of candidates for deputies of the lower house published in mass circulation in Uzbek, Karakalpak and Russian. In addition to this, political parties widely used other tools of election campaign (websites, banners).

Materials and speeches by representatives of political parties, candidates for deputies and election debates



were published in central and regional print media, as well as in party press. They were broadcast on central TV and radio channels «Oʻzbekiston» and «Yoshlar», regional TV and radio channels of Uzbekistan National Television and Radio Company, as well as on private television channel «NTT».

During the election campaign, political parties held 19,947 meetings in total with the electorate, including 4,364 by the Social Democratic Party of Uzbekistan «Adolat», 4,735 by the the Democratic Party of Uzbekistan «Milly Tiklanish», 5,591 by the Movement of Entrepreneurs and Businesspeople — Liberal Democratic Party of Uzbekistan, and 5,257 meetings by the People's Democratic Party of Uzbekistan.

The campaign was held within legal framework, voters had the opportunity to compare the electoral platforms of political parties, candidates for deputies of the Legislative Chamber, and to make an informed choice on the voting day.

The elections demonstrated the high socio-political activity, the growing level of political and civic consciousness of voters, broad popular support for persistent move of the nation toward intensifying democratic reforms, modernization of the country.

More than 15 million 108 thousand people representing 87.8 percent of those registered on the lists voted in elections of deputies to the Legislative Chamber of the Oliy Majlis and local representative bodies.

As a result of voting on December 27, 2009, deputies to the lower house of parliament were elected in 96 constituencies. Furthermore, in accordance with the Law «On elections to the Oliy Majlis of the Republic of

Uzbekistan», on the election day, the Conference of Environmental Movement of Uzbekistan elected 15 deputies to the Legislative Chamber of the Oliy Majlis.

Due to the fierce competition among political parties, none of the candidates succeeded to gain the necessary quantity of votes in 39 constituencies for the elections to the Legislative Chamber of Oliy Majlis. In this regard, on 30 December, 2009, the Central Election Commission approved a decision to hold the second round of voting on January 10, 2010, in those constituencies.

In the second vote, which in each of these districts was conducted between two candidates who received the biggest number of votes during major elections two weeks earlier, the electorate numbered 3 million 960 thousand citizens, representing 79.7 percent of voters listed in registers at those 39 constituencies.

Overall, the elections of deputies to the Legislative Chamber of Oliy Majlis produced 150 parliamentarians, including 53 from the Movement of Entrepreneurs and Businesspeople — the Liberal Democratic Party of Uzbekistan, 32 from People's Democratic Party of Uzbekistan, 31 from the Democratic Party of Uzbekistan «Milly Tiklanish», 19 from the Social Democratic Party of Uzbekistan «Adolat». 15 members of parliament are representatives of the Environmental Movement of Uzbekistan. In the lower house, practically all sectors of society are represented. Of the 150 deputies elected, 33 (22 percent) are women.

Among the elected deputies of the lower house of parliament 47 people, or 31.3 percent, have previously been members of the Legislative Chamber. This not only suggests that the elected members had won the confidence of their voters, but also the possibility for

more effective use of their life experience and practical skills in legislative creativity in the work of professional parliament.

In promoting transparency and openness of elections, participation of international and local observers, representatives of the media was of great significance. The broad coverage of the electoral process was provided by over 500 national and 200 foreign mass media.

Monitoring of elections to the Legislative Chamber of Uzbek parliament was carried out by more than 60 thousand observers and authorized representatives of political parties. Elections to the Legislative Chamber, local representative bodies have been attended by more than 270 observers from 36 countries and missions of four international organizations: OSCE / ODIHR, CIS Executive Committee , SCO and the OIC.

International observers were offered all necessary conditions for their activities. They had the opportunity to study the electoral law, get familiarized with the CEC, constituency and district election commissions, and provided with necessary information. They met with leaders of political parties and the Environmental Movement of Uzbekistan, candidate MPs, representatives of the media. On election day, they were free to visit polling stations and monitored the voting process, talked with organizers of elections and voters. Most of them have left notes in Guestbooks of international observers at polling stations, whereby they expressed their views, recommendations and feedback about the organization of elections.

Heads of observer missions from the OSCE / ODIHR and the CIS Executive Committee, as well as some



international observers participated in the Conference of the Environmental Movement of Uzbekistan on elections of deputies to the Legislative Chamber of Oliv Majlis of Uzbekistan.

Observers from international organizations and foreign countries were free to express their opinions about the organization and conduct of elections in Uzbekistan in interviews with representatives of overseas news agencies and local journalists. Heads of observer missions from international organizations held press conferences, made official statements on the outcomes of scrutiny. This collection includes views, assessments and wishes of a number of international observers.

In general, organization of polling stations deserves praise with the active participation of citizens of Uzbekistan in the voting process.

... At the polling stations visited by the Mission, we encountered observers from political parties of Uzbekistan, authorized representatives of candidates, as well as international osservers. Complaints and rebuke from those persons during the elections have not been reported to the Mission.

It is important to emphasize that the Mission had an exciting opportunity at its discretion to visit different polling stations, freely observe the elections and to obtain necessary information from constituency commissions.

The Mission has been present at counting the ballots and compiling the relevant protocols on voting results at polling places. During these procedures, violations of the law of the Republic of Uzbekistan «On elections to the Oliy Majlis of the Republic of Uzbekistan» were not discovered by the Mission.»
