It should be noted that Uzbekistan has created a stable legal framework that strengthens the priority of private property, which is the basis of a market economy. A favorable business environment and reliable legal guarantees have been created for the formation of the middle class, the sustainable development of the country's economy, the creation of new jobs and the rapid development of small business and private entrepreneurship, which is an important factor in increasing incomes. As a result, over the past decade, the share of small business in GDP increased from 31.1% to 52.5%, the employment rate in this sector increased from 49.7% to 74.5% of the total population employed in the economy. More than 47% of the population's income comes from entrepreneurial income [1].

One of the most important directions of economic reforms in Uzbekistan is the development of small business and private entrepreneurship. Special attention is paid to the development of small business in our country, taking into account the opportunities to solve the problem of employment, ensure the abundance of the market and increase the competitiveness of the economy.

Like all other sectors, it is necessary to carry out socio-economic reforms, ensure economic growth, modernize the industry, launch new production facilities, implement targeted programs, develop agriculture, support small business and private entrepreneurship. was performed (Fig. 1). In particular, a system of wide-ranging benefits and preferences for financial support of business initiatives has been created through the gradual improvement of the regulatory framework for economic reforms. Private property rights and its protection have been strengthened. In recent years, more than fifteen laws of the Republic of Uzbekistan, including the new edition "On protection of private property and guarantees of property rights", "On licensing procedures in the field of entrepreneurship", "On family business", "On guarantees of freedom of entrepreneurial activity" gi and other laws were passed. The activities of information and consultation centers, real estate agencies, enterprises assisting entrepreneurs in maintaining accounting documents have been improved in cities and districts. Law firms, brokerage houses, branches of commercial banks and branches of insurance companies began to develop, providing fast, convenient and reliable customer service. In addition, 167 permitting procedures, 19 types of licensed activities, as well as 65 types of statistics and 6 types of tax reporting have been abolished in the last 4 years, and the amount of fees for issuing permits has been halved [2]. The system of taxation of entrepreneurs, accounting and statistical reporting has been simplified. Conditions and opportunities have been created to increase the volume of exports of entrepreneurs' products. The scope of financial support for small business and private entrepreneurship is also expanding through the provision of soft and microcredits and the allocation of funds for the formation of start-up capital. Tax incentives were applied. The system of vocational education, information and communication system for small business and private entrepreneurship has been developed. In recent years, the legal framework for supporting small business and private entrepreneurship has

In recent years, the legal framework for supporting small business and private entrepreneurship has been radically updated. The role of the courts in the protection of business entities has been increased,

and some of the powers exercised by regulatory authorities for private business entities have been transferred to the courts. Registration and licensing have been simplified.

Our country has created a solid legal framework for the development of entrepreneurship, stimulating the activities of this sector, reliable protection of the rights and interests of small business and private entrepreneurship. In particular, Article 36 of the Constitution of the Republic of Uzbekistan states that "Everyone has the right to own property ... the right to inheritance is guaranteed by law." Small business and private entrepreneurship are related to private property, and the ownership, use and disposal of property is guaranteed by law. The Constitution of the Republic of Uzbekistan stipulates that the basis of the economy is various forms of property. Entrepreneurship is also analyzed as a type of economic activity, which is stated in Article 53 of the Constitution of the Republic of Uzbekistan: "The state guarantees freedom of economic activity, entrepreneurship and labor, equality of all forms of property and equal legal protection, taking into account the supremacy of consumer rights."

The norms of the Civil Code of the Republic of Uzbekistan also strengthen the regulation and guarantee of relations related to small business and private entrepreneurship. In particular, Article 164 of the Code stipulates that a property right is a person's right to own, use and dispose of his property voluntarily and for his own benefit, as well as to demand the elimination of any violation of his property rights by anyone. recorded. In general, the norms of the Civil Code regulate property and personal non-property relations of small business and private entrepreneurship.

Stimulation of the small business and private entrepreneurship sector in our country is one of the key strategic factors of socio-economic development of the republic. In the context of economic reforms in Uzbekistan, the main stages of supporting private entrepreneurship are in line with the stages of economic reform. As support for private entrepreneurship is an integral part of a market economy, a link that ensures its smooth functioning, it does not lose its relevance at every stage of the sector's reforms, even when market relations are fully operational.

In the wider involvement of small business and private entrepreneurship, special attention should be paid to the following issues:

- Expanding the access of small business and private entrepreneurship to loans, raw materials, as well as public procurement;

- Creation of organizational, legal, financial mechanisms and conditions necessary and favorable for the development of export potential of small business and private entrepreneurship;

- Establishment of systematic control over the allocation of targeted loans by government and nongovernmental organizations for small business and private entrepreneurship to start their own business and ensure their spending;

- Further improvement of the necessary legal and regulatory documents aimed at the formation and strengthening of the middle class through the further development of small business and private entrepreneurship among young people on the basis of modern requirements;

- It is necessary to increase the number of small enterprises processing agricultural products in the country;

- It is necessary to further increase the number of small enterprises processing secondary waste, producing industrial products;

- It is necessary to further increase the number of small enterprises engaged in the introduction of information and communication technologies in production.

This, in turn, will provide a solution to the problem of creating new jobs and thus the formation of effective intersectoral employment, increase incomes and strengthen mutually beneficial relations between different sectors.
